## RESUME OF BUSINESS TRANSACTED DURING THE FOURTH SESSION OF TENTH KERALA LEGISLATIVE ASSEMBLY

The summons for the Fourth Session of the Tenth Kerala Legislative Assembly was issued on 22-2-1997. The session commenced at 9.00 a.m. on Thursday March 6, 1997 and adjourned sine-die at 12.20 p.m. on Tuesday April 8, 1997. There were altogether twenty-one sittings. The House transacted business for 118 Hrs. 27 minutes.

### *Governor's Address:*

The Governor addressed the Members of the Legislative Assembly at 9.00 a.m. on Thursday March 6, 1997. As soon as the Governor began to deliver the address, the Leader of Opposition made a statement and walked out along with the entire Opposition Members. They abstained from the proceedings for the day.

The discussion on motion of Thanks commenced on March 10, 1997, with Shri Krishnan Kaniyamparambil moving the following motion:

*Statement by Minister:*

On April 8, 1997 Shri T. Sivadasa Menon, Minister for Finance made a statement regarding the extension of time till 31-7-1997 to remit the vehicle tax due for the quarter ending on 1-4-1997 and 31-7-1997 to scooters, motor cycles and private three wheelers.

*Motion for suspension of Rule:*

On March 19, 1997 the House adopted the following motion moved by Shri E. Chandrasekharan Nair, Minister for Food, Tourism and Law:

*Presentation of Petition under Rule 113:*

On March 26, 1997 Shri M. Murali presented a petition signed by Shri P. Vandevean, President and Shri M. K. Dasappan, General Secretary of Akhila Kerala Viswakarma Mahasabha praying for solving the problems faced by the persons belonging to Viswakarma community. The petition was referred to the Committee on Petitions.

Government Resolution:

On April 3, 1997 the following resolution moved by Shri Pinarayi Vijayan, Minister for Electricity and Co-operation was adopted by the House.

3. Complaint against the District Employment Officer, Thrissur for his misbehaviour in the meeting of the Estimates Committee held at Thrissur on 31-1-1997.

The Speaker also informed the House that the following notices of question of breach of privilege were under consideration:—

## III. *Reference of Bills to Subject Committees and Presentation of Subject Committees Reports:*

## **Financial Business**

### I. *Budget for 1997-98:*

The Budget for 1997-98 was presented by the Hon'ble Finance Minister on 14th March, 1997. The general discussion commenced on 17th March, 1997. Three days were allotted for general discussion on the Budget. The House devoted 15 Hrs. and 01 minute for this business. 55 Members participated in the discussion.

## II. *Vote on Account:*

The **Vote on Account** for the year 1997-98 was presented on 14th March, 1997. The discussion on the **Vote on Account** was held on 25th March, 1997. The **House** devoted 6 hrs. and 08 minutes for this business. 24 members participated in the discussion.

The Kerala Appropriation (Vote on Account) Bill, 1997 was introduced on 26th March, 1997 and was taken into consideration and passed on the same day.

## III. *Supplementary Demands for Grants for the year 1996-97:*

On March 11, 1997, Shri T. Swadasa Menon, Minister for Finance laid the Final Supplementary Demands for Grants for the year 1996-97. The discussion and voting on the Supplementary Demands for Grants took place. Members including Minister for Finance participated in the discussion.

The Kerala Appropriation Bill, 1997 in respect of the Supplementary Demands for Grants for the year 1996-97 was introduced in the Assembly on 21st March 1997 and was taken into consideration and passed on the same day.

## **Private Members' Business**

According to the Calendar of **Sittings of the Fourth Session of the Tenth Kerala Legislative Assembly**, Private Members' Business was set down for two days viz., on March 21 and April 4, 1997. Of these, **March 21, 1997** was set apart for transacting the business relating to Private Members' Bills and **April 4, 1997** for Private Members' Resolutions.

### *Private Members' Bills:*

During the Session, ten Motions for leave to introduce Bills came up before the House. But only nine were introduced. The motion for leave to introduce the Bill "The Kerala Shop Establishment Workers' Welfare Fund Bill, 1997" sought by Shri K.P. Rajendran, M.L.A. could not be introduced since the member concerned was absent.

Discussion on motion for leave to introduce three Bills was scheduled. But discussion on motion for leave to introduce only two Bills could be resumed and completed, and the Bills were withdrawn by leave of the House on the basis of the replies given by the Ministers concerned. Since Shri Johny Nelloor was absent, the continuation of discussion on the Bill "The Kerala Cine Artists and Cine Workers' Welfare Fund Bill, 1996" could not be resumed.

The details regarding the names of Bills and the names of members who moved the motions for leave to introduce the Bills and the result thereof are given in the Appendix VIII & IX.

*Private Members' Resolutions:*

The discussion on the resolution given notice of by Shri P. Raghavan which was moved on 13-9-1996 and not completed, was resumed. Two members who had given notice for amendment to the resolution participated in the discussion. In the absence of the Minister for Electricity and Co-operation, the Minister for Welfare of Backward and Scheduled Communities also participated in the discussion. The resolution was passed by the House unanimously.

Two new resolutions given notice of by Shri M. Narayanan (Coyalmannam) and Shri P.T. Kunhi Muhammed also came up before the House during the Session. Ten members and in the absence of the Minister for Forests and Transport, the Minister for Health and Sports participated in the discussion on the resolution moved by Shri M. Narayanan (Coyalmannam) and the resolution was passed unanimously by the House. In the absence of and as authorised by Shri P.T. Kunhi Muhammed, Shri Kadakampally Surendran moved the third resolution. Two members participated in the discussion and the discussion was incomplete.

The details regarding the name of the Members who moved the resolutions, the text of the resolutions and the result thereof are given in Appendix X and XI.

The House devoted a total of 3 hours for transacting the Private Members' Business.

## ANNEXURE VI

## SALIENT FEATURES OF IMPORTANT BILLS

1. *The Kerala-Cutchi Memons Bill, 1996.*

The law governing succession and inheritance of Cutchi Memons in the State is now contained in the Travancore Cutchi Memons Act, 1117 (XIV of 1117), the Cutchi Memons Act, IV of 1166 (Cochin Act) and the Cutchi Memons Act, 1938 (Central Act 10 of 1938). It is considered expedient to have a single enactment applicable to the Cutchi Memons in the State.

The Bill is intended to achieve the above object.

2. *The Kerala Motor Transport Workers' Payment of Fair Wages (Amendment) Bill, 1997*

The Kerala Motor Transport Workers' Payment of Fair Wages Act, 1971 is an Act to provide for payment of fair rates of wages to Motor Transport Workers in the State. The Schedule to the said Act provides the rate of fair wages payable to a motor transport worker. The Schedule to the said Act was amended in the year 1986 for the purpose of revision of pay scale and other allowances of a motor transport worker. Government have decided to revise the existing fair wages applicable to the employees of Motor Transport Industry in Kerala based on the recommendation of a Committee appointed for the purpose by suitably amending the Act.

As the Legislative Assembly was not in session and the Fair Wages of the Workers of Motor Transport Industry had to be revised immediately. The Kerala Motor Transport Workers' Payment of Fair Wages (Amendment) Ordinance, 1996 was promulgated by the Governor on the 9th day of January, 1997 and published as Ordinance No. 1 of 1997 in the Kerala Gazette Extraordinary No. 68 dated the 15th January, 1997.

This Bill seeks to replace the said Ordinance by an Act of State Legislature.

#### 4. *The Payment of Salaries and Allowances (Amendment) Bill, 1997*

As per sub-section (6) of section 8A of the Payment of Salaries and Allowances Act, 1951 (XIV of 1951) every member of the Legislative Assembly is entitled to the service of an officer of his choice not above the rank of a Senior Grade Assistant in the Government Secretariat and who is in the service of the Government or local authority or any Corporation owned or controlled by the Government or any other authority specified by the Government in this behalf to assist him in the performance of the duties of such member.

As per G.O. (Ms) No. 101/95/Fin. dated 31-1-1995 one third of the posts of Senior Grade Assistants of the Secretariat were converted as Selection Grade Assistants. The posts of Selection Grade Assistant is also below Gazetted rank and there is no change in the nature of their duties. Government have decided to include the post of Selection Grade Assistants also under the purview of sub-section (6) of section 8A of the above Act by amending the Act suitably.

The Bill seeks to achieve the above objects.

#### 5. *The Kerala Payment of Pension to Members of Legislature (Amendment) Bill, 1997*

The provision to sub-section (2) of section 2 of the Kerala Payment of Pension to Members of Legislature Act, 1976 enables the members to draw pension along with salary where the salary is less than pension payable to him under sub-section (1) of that section. Government proposes to discontinue the system of drawal of pension by a sitting member and also to limit the maximum pension payable to a member to Rs. 5000 (Rupees five thousand only) per month by suitably amending the Act.

The Bill seeks to achieve the above objects.

#### 6. *The Kerala Agricultural University (Amendment) Bill, 1997*

It is considered necessary to include the Agricultural Production Commissioner, the Principal Secretaries, Secretaries or Special Secretaries, as the case may be, in the Departments of Animal Husbandry, Co-operation, Fisheries,

and Forest also in addition to the Principal Secretaries etc., of the Agriculture, Development and Finance Departments to the General Council of the Kerala Agricultural University. It is also proposed to give due representation to the Grama Panchayats, Block Panchayats and the District Panchayats in the State to the General Council of the said University consequent to the formation of Panchayats, at these levels in the State, by the Government. It is also proposed to include the representatives of the Agro based corporation etc. in the State, a farmer who is the winner of State award for Agriculture and two permanent labourers of the University also as members of the General Council of the University.

It is considered necessary to include the Agricultural Production Commissioner, the Principal Secretaries etc. of the Animal Husbandry, Co-operation, Fisheries and Forest Departments, in addition to the Principal Secretaries etc. of the Agriculture, Development and Finance Departments and five eminent scientists in the field of agriculture and allied subjects, nominated by the Chancellor, as recommended by a Committee as provided in the Bill also as members of the Executive Committee of the said University.

It is proposed to confer power on the Pro-Chancellor to over see the functioning of the University whenever such a need arises.

At present no upper age limit is fixed for holding the office of the Vice-Chancellor of the University. It is proposed to fix sixty-five years as the upper age limit for a person to hold office of Vice-Chancellor.

According to sub-section (1) of section 27 of the Kerala Agricultural University Act, 1971, the Pro-Vice-Chancellor or in his absence the senior most Dean shall carry on the routine duties of the office of the Vice-Chancellor. It is considered necessary to empower the Pro-Vice-Chancellor to carry on the duties of the Vice-Chancellor in the event of temporary or permanent vacancy in that office and also to confer power on the Chancellor to make arrangements for exercising the powers and performing the duties of Vice-Chancellor in the absence of the Pro-Vice-Chancellor.

Sub-section (1) of section 29 of the said Act provides that the Pro-Vice-Chancellor may be appointed by the Chancellor in consultation with the Vice-Chancellor and the Executive Committee. Consultation in this case proposed to be made with the Pro-Chancellor, instead of the Vice-Chancellor and the Executive Committee.

The above proposals are intended to involve eminent scientists and other persons having expertise in the field of agriculture and allied subjects in the affairs of the University with the view to utilise their expertise and service for the development of agriculture in the State also to provide for the efficient administration of the University.

The Bill seeks to amend the Kerala Agricultural University Act, 1971, to achieve the above objects.



7 *The Kerala Co-operative Societies (Amendment) Bill, 1996*

In the Long Term Fiscal Policy announced by the Government of India it was resolved to simplify and rationalise the laws relating to direct taxes. Accordingly, it has been decided that financial year ending with the 31st March be adopted as the uniform accounting year for tax purposes. This may require all assessors of Direct Tax Laws, including Co-operative Societies to disclose their incomes for income tax purposes for the year ending with the 31st March every year instead of the 30th June (i.e. 1st October), as section 2 of the Kerala Co-operative Societies Act, 1989, as the period commencing on the 1st day of April of any year and ending with 31st of March of the succeeding year, instead of commencing on the 1st day of July, of any year and ending with 30th of June of the succeeding year, as stands at present.

The Bill is intended to achieve the above object.
